Ordered, that in the meantime and until the hearing of the motion brought on by this order to show cause, and the entry of an order thereon, Respondent NG Advantage, LLC is hereby temporarily restrained from taking any action pursuant to the May 23, 2017 Site Plan Approval at 65, 69, & 93 West Service Road, Binghamton, New York, including, but not limited to site preparation or construction;

Pursuant to CPLR § 2512, Movant Chenango Valley Central School District will not be required to post a bond;
